

Summary Annual Report

For Emeriti Retiree Health Plan for Saint Mary's College

This is a summary of the annual report for Emeriti Retiree Health Plan for Saint Mary's College, Employer Identification Number 35-0868158, Plan No. 503 for the period January 1, 2010 through December 31, 2010. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The plan has contract(s) with AETNA LIFE INSURANCE CO, AETNA LIFE INSURANCE CO, AETNA LIFE INSURANCE CO, AETNA LIFE INSURANCE CO and AETNA LIFE INSURANCE CO. to pay all medical claims incurred under the terms of the plan. The total premiums paid for the plan year ending December 31, 2010 were \$454,271.

Basic Financial Statement

Plan expenses were \$484,820. These expenses included \$22,601 in administrative expenses and \$462,219 in benefits paid to participants and beneficiaries.

The value of plan assets, after subtracting liabilities of the plan, was \$1,647,119, as of December 31, 2010 compared to \$1,212,639 as of January 1, 2010. During the plan year, the plan experienced an increase in its net assets of \$434,480. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$919,300, including employer contributions of \$679,518, employee contributions of \$74,753, and earnings from investments of \$165,029.
