Additional Unsubsidized Direct Request



My parent does not wish to appeal the denial of the Federal Parent PLUS loan, or the appeal has been denied, so I wish to borrow the additional unsubsidized Direct Loan. I understand that the interest on this loan will accrue while I am enrolled in school, and that the maximum amount I may borrow is determined by my class level in college (according to the number of credit hours I have earned):

Freshman	\$4,000
Sophomore	\$4,000
Junior	\$5,000
Senior	\$5,000

- I DO want to borrow the additional unsubsidized Direct Loan because my parent was denied a Direct Parent PLUS loan. I request that the maximum annual amount (or a reduced amount of: _____) be added to my financial award and certified for me. I understand I will still have the right to accept or deny the loan funding when it disburses to my account, and I will be notified by Student Accounts when the funding arrives.

In order to receive this additional Direct funding I know that I must complete the following step, if I have not already done so:

If I am a first-time Direct Loan borrower at Saint Mary's College I must apply for a Direct Loan by completing the entrance counseling **and** signing a Master Promissory note at www.studentloans.gov.

If I am a returning federal student loan borrower at Saint Mary's College (in other words, I had a Stafford Loan in 2009-10), I must sign a new promissory note with the Direct Loan program at www.studentloans.gov.

- I DO NOT want to borrow the additional unsubsidized Direct Loan funding even though my parent was denied a Parent PLUS loan.
